**SPECIAL TOWN MEETING**

- Article 1: To see if the Town will vote to transfer the sum of Ten Thousand One Hundred Seventy Nine dollars (\$10,179) from Free Cash to fund an asset audit to satisfy the GASB34 reporting requirement or take any action thereon.  
***Voted to transfer \$10,179 from Free Cash to fund the asset audit 23 – 0.***
- Article 2 : To see if the Town will vote to direct the Board of Selectman to enter into a five year lease Agreement with National Grid, establishing rules for the use of National Grid poles for Town owned streetlights, or act anything thereon.  
***Article passed as read – 26-0.***
- Article 3 To see if the Town will vote to transfer the sum of Five hundred dollars to the Animal Control Expense account or take any action thereon.  
***Voted to transfer from Stabilization the sum of \$400.00 to the Animal Control Expense Account. 26-0***
- Article 4: To see if the Town will vote to transfer or take from available funds a sum of money for the Public Hall account or act anything thereon.  
***Voted to transfer from Stabilization the sum of \$4,000.00 to the Public Hall Account. 24-0***
- Article 5: To see if the Town will vote to transfer or take from available funds the sum of Twenty-four Thousand five hundred four dollars and fifty-two cents (\$24,504.52) to balance the snow and ice account or take any action thereon.  
***Voted to transfer from Stabilization the sum of \$24,504.52 to the snow and ice account. 24-0***

Article 6: To see if the Town will vote to transfer to Stabilization the following sums of money , or take any action thereto.

***Voted to table the article 20-0. Article Tabled.***

Article 8: To see if the Town will vote to transfer the sum of Two Thousand dollars ( \$2,000) to the DPW fuel account for Police Department fuel to finish Fiscal year 2007 or act anything thereon.

***Voted to transfer from Stabilization the sum of \$1,000.00 to the DPW fuel account. 27 – 0.***

Article 9: To see if the Town will vote to fund the Athol Summer Playground program for the sum of \$2,100 for Royalston children's participation or act anything thereon.

***Voted to take from Stabilization the sum of \$2,100.00 to fund the Athol Summer Playground program for Royalston children's participation. 20 in favor, 5 opposed.***
