Article 2: Voted to transfer from Stabilization the following sum of money:
Article 43 Annual Town Meeting May 2005, Snow & Ice \$28,243.58
20 in favor, 0 opposed.

Article 3: Motion made to transfer Three Thousand Two Hundred Twenty Six Dollars and Sixty Four Cents (\$3,226.64) from Stabilization to the LIG/MEG Library account to correct FY01 posting errors and the proper balance to the account. 12 in favor, 7 opposed – defeated. (Required 2/3 vote) Later voted to reconsider this article, 37 in favor, 0 opposed. **Article passed as read, 39 in favor, 1 opposed.**

Article 4: Voted to transfer from Stabilization the sum of Seven Thousand Dollars (\$7,000.00) to pay fiscal year 2006 bills for the Board of Health.
24 in favor, 1 opposed.

- Article 5: Voted to transfer the amount of One Thousand Seven Hundred Dollars (\$1,700.00) from the FY 2006 Public Halls Account to the Public Halls Maintenance Account or take any action thereon.
31 in favor, 0 opposed.
- Article 6: To see if the Town will vote to take from Stabilization the amount of Twenty Eight Dollars (\$28.00) to pay a legal bill from FY 2005 or take any action thereon. Voted to table the article. **31 in favor, 0 opposed. Article tabled.**
- Article 7: Voted that the Town of Royalston, in accordance with G.L. c. 40, section 4A, authorize the Board of Selectmen, in consultation with the Board of Health, to enter into an intermunicipal agreement with one or more governmental units to provide public health services which the Board of Health is authorized to perform, in accordance with an intermunicipal aid agreement to be entered into between the Town and various governmental units. **34 in favor, 0 opposed.**
- Article 8: Voted to take from Stabilization the amount of Fifteen Thousand Dollars \$2,508.33 for the purpose of servicing short-term debts.
37 in favor, 0 opposed.

- Article 9: To see if the Town will vote to take from available funds the amount of Two Thousand Five Hundred Ninety-Nine Dollars (\$2,599.00) to replenish the police department patrol budget, these funds having been reimbursed to the General Fund by the US Army Corps for FY 2006 patrols, or take any action thereon.
Voted to table this article, 36 in favor, 0 opposed. .
- Article 10: To see if the Town will vote to take from available funds the amount of Four Hundred Dollars (\$400.00) to be added to the Inspector of Building's expense account for expenses of FY2006 or take any action thereon.
Voted to table this article, 37 in favor, 0 opposed.
