Remove section of picket fence and add gate to allow for pedestrian and handicapped access to Athol Rd. via the west side of the property. Install a gate matching the existing walking gate at the north side of the property. Replace fence on either side of the new gate with matching pickets and posts. Entire fence including changes will be subsequently cleaned and painted the existing white color. Acorn/ urn ornaments will be added to the gate post tops on all three gates to match those at #10 across the street creating a uniformity in the appearance of both properties.
