Thank you for your message. I am moved to learn that you have some of my early photographs taken in the lovely town of Royalston. I am sad to report that after moving to California to teach at Berkeley, my home and almost all of my work was destroyed in the Oakland Firestorm of 1991 - and thus quite likely the negatives of these photographs no longer exist.

I give you permission to post the photos on your website - and in return, I would like to ask you the favor of providing for me scans of them at as high a resolution as is practical, prior to their being compressed for web viewing. (They can be sent to me in a Zip file using one of the free large file transfer sites like www.transferBIGfiles.com rather than attaching photos to an email.) This will be a favor to me as, of course, I no longer have this early work of mine.

My websites below do show my publications, and the top one includes my CV and copies (scanned) of other images the prints of which survived the fire.
