The applicant will supply additional information: Shutter height, width, and window height and width. Andy made a motion to accept the application for consideration. Roger seconded. - 2. Doors to replace garage door on small barn: Two swing open doors to replace an overhead garage door. - 3. Front Porch: Modify existing style. The applicant will supply additional information: Itemized materials, scaled, dimensioned drawings showing front and side elevations, crown molding profile and size, color sample of ceiling paint. - 4. Window change: Change windows in bay from 2 over 2 to 6 over 6 pane window. Andy made a motion to accept the application for consideration. Rick seconded. The motion carried. Bob Casinghino abstained. A public hearing will be scheduled for 7pm, Thursday, June 15, 2006.
- 5. Sign over Barn Door: 16 inches high by 10 feet long. The applicant will supply additional information: Scaled drawing with dimensions including placement of sign relative to windows. Andy made a motion to accept the application for consideration. Rick seconded. The motion carried. Bob Casinghino abstained. A public hearing will be scheduled for 7pm, Thursday, June 15, 2006.
