We converged on filing an application after the mock-ups are available and then organizing a public hearing focusing on the sign design. The Selectboard would be contacted in parallel. After the hearing we would post a notice in the newsletter about the upcoming installation.

Pierre reported that John didn't seem to have removed the front vinyl windows installed without authorization but might have installed new approved windows on the West side. The certificate of appropriateness will expire in May. We decided not to take any formal action at this time but to send a reminder letter before the expiration date of the certificate.
