It was pointed out that the roofing problem should be settled by the Selectmen and this Commission and for the present the Commission should keep a low profile.

No input has been received from Kate Collins regarding her findings on the slate roofing problem.

The fence surrounding the Peter Pap property still has unsightly tapes on it. The fence has been changed from the wooden one to a single strand electric wire. The questions this brings up are: What does the Commission object to? What is the violation? The tapes are to be removed when the new horse has adjusted to the pasture. It was agreed that the owner should be notified verbally regarding the white tapes and Bob Gravley will phone him.

Some time ago the church needed an immediate approval to tear down the old building behind the Lions club. At time request was submitted the church indicated it was of immediate concern to them. It still has not been torn down and Patience Bundscuth will contact Barney Stearns regarding its removal.

The historic survey that has been on going for sometime now needs to be completed. Discussion of several houses was made and each group is to pick examples of type of house in their area as being typical and then say how many of the same type are in the area. The houses are to

be separated according to architecural style.

New Business: A committee is to look over a newsletter presented by Bob and to present finding at next meeting. It is a letter that could be used to present to area residents when needed. The Committee is to condense the by-laws , using the newsletter as a guide.

ROYALSTON HISTORIC DISTRICT C OMMISSION MEETING May 12, 1983

Meeting was called to order by Bob Gravley; minutes of the last meeting were not read.

Two guests were present: Dr. Dwight Stowell, selectman and Georfrey Newton, building inspector.

Patience Bundscuth presented a paste up of the "Communication pamphelt" and discussed methods for reproducting copies. She also asked for additional clarification of the term "hardship".

Tom Musco raised the possibility of obtaining tax deduction for those individuals providing professional volunteer services. i.e. P. Bundscuth. for the Commission. It was agreed that the Chairman would acknowledge these services in the form of a written note when so requested.

The Selectman and the Building Inspector were invited to this meeting to discuss means for cooperatively achieving implementation of the Historic District By-laws. The salient points of the discussion that followed are noted as fallows.

- 1. Dr. Stowell suggested a review of the By-laws and stated that in a small town such as Royalston the Commission should show more flexibility in the interpretation of the by-laws, He asked that the Commission not make it too difficult to live in the district.
- 2. The Building Insoector had not seen, and therefore had not read the Historic District By-laws for the town of Royalston. However he stated that he felt that he could make the decisions when the building permits submitted to him complied with the By-laws. Several Commission members pointed out that the Commission was charged with the interpretation of the provisions of the By-laws and were responsibile to the State Commission.

The Building Inspector was asked to report and requests for changes to the Commission and thus help us prevent problems of non-certification, before they arise, such as the Chaissen, Willis and French episodes. It was empthasized that when in doubt, ask the owner to file. The Secretary will provide the Building Inspector with copies of the By-laws and application forms. As the Building Inspector left he promised to copperate and to refer all changes to the Commission.

Through the discussion it became apparent that interpretation of VISTA should be reviewed.

Wayne Newtip re-submitted the Kymalianen application with drawings showing the changes requested. The Commission accepted the application as being complete and agreed to hold a public hearing on the application on June 16, 1983
