On behalf of the Common Restoration Committee, Clarence Rabideau filed an application to remove the flagpole from the monument and install a new one further to the west. As discussed previously, the current flagpole movements are one of the main reasons for the degradation of the marble block. Pierre made a motion to accept the application for consideration with a public hearing at the February meeting. Bob seconded. All voted in favor. Application 2014-01-1.

On behalf of the Common Restoration Committee, Clarence Rabideau submitted another application to restore the monument, following the removal of the flagpole. However many important details were still pending and the feeling was that this application was premature and should be resubmitted.

Bob Casinghino then explained the circumstances that forced him to install a granite step before filing the application in December. Clarence made a motion to accept the application for consideration without requesting a public hearing. Rick seconded. All voted in favor, except Bob who recused himself. Application 2013-12-1
