OLD BUSINESS

on June 17 1999 Eldora Bowers

so a vote is appropriate.

a discussion follows about ^{Certificates of} hardship -
and how they affect future owners
of the property.

many pts are noted:

hardship is granted to a person - not
property - so future owners are held
to different standards

if a paint exists when a property
transfer takes place is it ~~it~~ not
then an existing color - and no
notice to HDC is necessary for
repainting - in this way the trim
could always stay lavender

a long discussion ensues - P. Bundschu argues that we must have closure and take a vote - this has all gone on too long - and has caused public opinion to be colored. - this cannot continue.

Rick Carrier makes a motion to vote on the app. with the proviso that the next time it is painted it will be applied for
