## Meeting Minutes

Attendees: Patience Bundschuh, Rick Carrier, Clarence Rabideau, John Divoll, and Andy West, acting secretary. All were active voters.

Meeting called to order at 7:45 PM

Minutes read and approved as amended.

### Applications

Steve Chase submitted an application to erect a playhouse across the street from his house on Northeast Fitzwilliam Rd. Discussion followed as to whether an application was in fact needed for such a structure. Steve said that his plans were not solidified as to the final size and details of the structure. It was decided that the members would visit the site and communicate to Patience their opinion so that Steve could be notified before the next meeting that he would need to prepare a formal application.

Andy West submitted an application from Pat Jackson at 7 Old Winchendon Rd to install an electric light beside the east doorway of the main house and beside the ell door. He also read some remarks from her stating her reasoning for choosing two different style lights and that if the two different lights do not go well together she will apply to change one. There was some concern that the photographs on the application did not include dimensions of the location of the light. John Divoll made a motion to accept the application with the condition that dimensions be filled in before the application is acted on. Clarence Rabideau seconded. Approval was unanimous. Rick made a motion to waive public hearing. John Divoll seconded. Approval unanimous.

Andy West will contact Mrs. Carbone and inform her of this.


