JUNE 27, 2020

I, Barbara Richardson, as Town Clerk of Royalston, do hereby certify that the following are the actions taken at the Annual Town Meeting of June 27, 2020.

The Annual Town Meeting was called to order by Moderator George Northrop at 10:09 AM with 85 of 964 registered voters in attendance. After briefing the audience on the general housekeeping rules such as encouraging the wearing of masks, using marked entrances and exits and sanitizing of microphone due to the COVID-19 pandemic, and acknowledging that perhaps the first al fresco/outdoor town meeting in recent memory was about to commence.

George then took time to acknowledge the recent passing of his predecessor Wayne Newton who served many years as moderator, fire chief and as a member of many town boards. We are all grateful for his service to the Town of Royalston.

Deb D'Amico chair of the Select Board addressed the audience explaining that the warrant is a very conservative version due to the COVID shut down. Not being able to predict the State aide we will receive; the recommendations are almost all level funded. The Select Board anticipates that the State will finalize a budget sometime this summer and then a Special Town Meeting will be held to adjust the numbers once we have them.

Article 1. To choose one or more persons to act for the Town in lawsuits.

Moved to choose K.P. Law to act for the Town in lawsuits, seconded.

Motion carries with 2 opposed.

Article 2. To see if the Town will vote to transfer from available funds in the Treasury, any sums of money to meet the appropriations under this warrant.

Move article as read, seconded. Motion carries unanimously.

Article 3. To see if the Town will authorize the Town Treasurer, with the approval of the Select Board, to borrow money from time to time in anticipation of revenue for the fiscal year beginning July 1, 2020 and to issue or renew notes as may be given for a period of less than one year, in accordance with Section 17, Chapter 44 of MGL as amended.

Moved article as read, seconded. Motion carries unanimously.

Article 4. To see if the Town will vote to fix the FY2021 salaries and compensation of all elected officers of the Town as provided by Massachusetts General Laws, Chapter 41, Section 108.

Moved article as read, seconded. Motion carries unanimously.

Article 5. To see if the Town will vote pursuant to the provisions of MGL, Chapter 44, Section 53E-1/2 as most recently amended, to establish a new FY2021 spending limit for the Post Office Revolving Fund, as set forth below and listed in Section 1 of the General Bylaw entitled "Revolving Funds" approved under Article 5 of the May 10, 2019 Annual Town Meeting, with such new limit to be applicable from fiscal year to fiscal year until revised by Town Meeting prior to July 1 for the ensuing fiscal year.

Article 6. To see if the Town will vote to accept and appropriate the sum of \$700,000 or such other amount as is made available for engineering, plans and authorized roadwork according to the provisions of MGL, Chapter 90, and/or STRAP grant, the same to be spent with the approval of the Select Board and Mass DOT.

Article 7. To see if the Town will vote to raise and appropriate, or transfer from available funds, the sum of \$52,171 to balance the FY2020 Snow and Ice Account.

Moved to transfer from Stabilization the sum of \$52,171 to balance the Snow and Ice Account, seconded.

Motion carries with 2 opposed.

Article 8. To see if the Town will appropriate the amount of \$70, 275 to operate the Wastewater Treatment Plant and Sewer System for FY2021, the amounts to be raised from user fees.

Moved article as read, seconded. Motion carries with 2 opposed.

Article 9. To see if the Town will vote to transfer from the Capital Stabilization Fund the sum of \$1,300 for FY2021 capitol expenditures for the Sewer System, including any incidental and related costs.

Moved article as read, seconded. Motion carries with 6 opposed.

Article 10. To see if the Town will vote to appropriate the following amounts, totaling \$174,692, to operate the Broadband Enterprise for Fy2021, the amounts to be <u>raised from user fees.</u>

Article 23. To see if the Town will vote to transfer \$7,000 from the FY20 Community Preservation Fund Open Space Reserve and \$18,000 from the FY20 Community Preservation Fund Budgeted Reserve, for a total of \$25,000.00, for the purpose of designing and constructing a Gazebo in South Village Park for recreation use, including all incidental and related costs.

Article 24. To see if the Town will vote to transfer \$45,000 from the FY21 Community Preservation Fund Reserve, for the purpose of replacing asbestos shingles on Raymond School, located at 3 Raymond Place, Royalston, with new shingles that will be historically similar, as approved by the Historic District Commission, including all incidental and related costs.

Article 25. Moved to table this article, seconded. Voted to table the article with 1 opposed.

Article 26. Moved to table this article, seconded. Voted to table the article unanimously

Article 27. To see if the Town will vote to transfer from Free Cash the sum of \$1,900 to fund a portion of cost for the cleaning and structural inspection of the Town water tank located at Pleasant Street, including all incidental and related costs.

Moved article as read, seconded. Motion carries with 1 opposed.

Article 28. To see if the Town will vote to authorize the Assessors to use a portion of funds in the Treasury to reduce the tax rate for the coming year.

Moved article as read, seconded Motion carries with 15 opposed.
